Please note that as a consequence of the de-registration of this aircraft, any Certificate of Airworthiness or Permit to Fly that was in force over this aircraft will be revoked. You will receive a separate communication detailing the suspension and revocation process. Following revocation, if the aircraft is returned to the UK Register of Civil Aircraft in the future then you must contact the Approvals and Certification Section on 0330 022 1908, email apply@caa.co.uk or see www.caa.co.uk/airworthiness for information on the grant of a new certificate of airworthiness or permit to fly.

Failure to do so could result in an unsafe condition occurring on future flights the aircraft might make under its new registration.
